Choose Your Membership Category:

_____ **ALLIANCE MEMBER** \$125 year

Most members are in this category. Membership is for one individual.

*Definition: A woman, or man, who is a business owner, independent contractor or commission-based professional. *If an employer reimburses you for this expense you must sign up as a Corporate Member.*

_____ **ALLIANCE PARTNER MEMBER** \$100 year

Alliance add-on membership. Membership is for one individual.

Definition: A discounted second membership for a business partner, woman or man, of a current Alliance Member. This add-on membership allows a second representative to attend events at the same time as the primary member.

_____ **AFFILIATE MEMBER** \$75 year

Membership is for the primary representative of an organization or for an individual.

Definition: A retired business professional, or a student, or a representative of a non-profit or trade association. One designated member per organization. One organization representative per meeting.

_____ **AFFILIATE PARTNER MEMBER** \$50 year

Affiliate add-on membership. *Definition: A discounted second membership for an additional representative, man or woman, of a non-profit or trade association. This add-on membership allows a second representative to attend events at the same time as the primary member.*

_____ **CORPORATE MEMBER** \$300 year.

Membership is for the primary representative. *A professional woman or man associated with a company that wishes to lend support to the organization. One designated member per company. One company representative per meeting.*

_____ **CORPORATE PARTNER MEMBER** \$150 year

Corporate add-on membership. *Definition: An add-on second membership for an additional representative, man or woman, from an organization. This membership allows a second representative to attend events at the same time as the primary member.*

_____ **ENTERPRISE MEMBERSHIP** \$500 year.

Alternative to corporate membership. *Definition: Allows up to five representatives from a single organization to have membership privileges. This is an ideal alternative to the corporate membership or sponsorship add-on since this allows several employees or representatives to attend meetings at the same time.*

AWOB Membership:

Membership is open to any woman who owns her own business, is a partner in a business, is an independent contractor (1099), or is a commission-based professional. Membership is also open to business men, business students, retired business owners, non-profits, companies or trade associations that support women who own their own businesses, and any non-business owner who wishes to lend support to the organization and its mission. Same or similar businesses in every category are welcomed. All members have voting privileges. AWOB serves women business owners in Pierce, Mason, Kitsap and Thurston counties in Washington State.
